2. 4. That it is his or her personal responsibility to ascertain the adequacy of training and experience of Participant and his or her horse for the event and to conduct himself or herself in a manner such as to make the event safe and enjoyable for the undersigned, and all participants.
5. As reciprocal assistance to NVRHA for privilege of membership, participation in approved events, the NVRHA may use any photograph or other form of likeness reproductions of a member, event participant, horse owner or their horses, and registered equine name to promote NVRHA objectives and activities including, but not limited to, use by third parties with authorization from NVRHA.
6. All participants agree to adhere to and follow all CDC and all federal, state and local guidelines regarding COVID 19 & social distancing while participating in NVRHA events.
