Liability Release, Assumption of Risk, and Indemnification and Promise Not to Sue

Please carefully read this agreement, complete and sign it. No one will be allowed to participate in any event at Double F Arena, LLC 35736 Hinckley Road, Hinckley, Minnesota 55037 unless he/she agrees to the term of this agreement, has completed and signed it. By signing this agreement you give up your right to recover any compensation for any personal injuries, damage to your property, or for your death, arising out of your participation in this event. You are releasing all entities and individuals associated with this event. This agreement is binding on you, your heirs, your next of kin, assigns and personal representatives. If a participant is a minor (under 18 years of age) this agreement must be agreed to and signed by a parent or legal guardian giving permission for child to participate in said event.

This Agreement, made of ____ day of _____ 20 __, between Double F Arena, David Falconer and Shoshana Englard-Falconer (hereinafter referred to collectively as "said entities") and the person executing this release,(hereinafter referred to as "participant").

IN CONSIDERATION FOR BEING PERMITTED TO PARTICIPATE IN THE EVENT(S) TAKING PLACE AT DOUBLE F ARENA IN HINCKLEY, MINNESOTA, I assume the risk associated with riding, and being near horses and livestock, including serious bodily injury and death. Warning! Riding horses and livestock, and being near horses and livestock is dangerous! I am aware of the inherent risks associated with these activities and I agree to assume them. I understand the risks involved with me and/or my child participating in rodeo activities and understand it may be hazardous to my and/or their health and/or well-being, I assume full responsibility for all risk of my and/or my child's bodily injury, death or property damage while at Said Entities and/or while participating in any activities or events there or in the future.

I further agree, for myself, my heirs, relatives, executors, administrators and assigns, to release, discharge and hold harmless Double F Arena, LLC; David Falconer and Shoshana Falconer, (herein after "Said Entities, including but not limited to its owners, officers, directors, employees, agents, sponsors, and any affiliated or related entity, committee, contractor or company, of any and all liabilities, claims, actions, damages, costs or expenses, of whatever kind or nature, which I may have against them arising out of or in any way connected with me and/or my child's participation in such events providing such claims arise from negligence. This agreement covers all activities at Double F Arena, and travel to and from event(s), including personal bodily injuries, death, and/or property damage which may be suffered by me before, during, or after the event(s). I understand that this waiver and release is based on claims of negligence (only) of any of the releases.

I promise not to sue said entities. However if a claim or lawsuit is made against Said Entities, for any injury or damage brought by or allegedly attributable to my presence at Double F Arena, or any activity associated with this event, I will pay all attorney's fees and costs reasonably incurred to defend the claim or lawsuit, and I will reimburse, indemnify said entities for any judgment, expense or damage incurred.

I agree that this release assumption, indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the state of Minnesota and that if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This document contains the entire agreement between the parties to this agreement and the terms of this agreement are contractual and not a mere recital.

As a condition of participation in the NVRHA Program and in consideration of being allowed to participate, the Participant, together with his or her parents or guardian if under the age of 18 years, agrees and acknowledges:

1. To obey all rules of the NVRHA Program and the directions of the clinicians, judges, and other representatives of the NVRHA organization which sponsors an event.
2. To assume risk of illness, injury and/or property damage arising from known or unforeseeable causes, and releases and discharges the NVRHA and its subsidiaries and affiliated entities, and the ranch of organization, the event, their officers, directors, representatives, and employees, from any and all liability, whenever or however arising as to illness, injury or property damage, occurring as a result of participation in an NVRHA event.
3. Warrants and represents that he or she is a qualified and experienced horseman, adequate to both (a) safely handle Participant's horse in a manner to protect Participant and other Participants, and (b) participate with groups of riders and horses, such as to take adequate defensive action to avoid injury from third party riders and horses.
4. That it is his or her personal responsibility to ascertain the adequacy of training and experience of Participant and his or her horse for the event and to conduct himself or herself in a manner such as to make the event safe and enjoyable for the undersigned, and all participants.
5. As reciprocal assistance to NVRHA for privilege of membership, participation in approved events, the NVRHA may use any photograph or other form of likeness reproductions of a member, event participant, horse owner or their horses, and registered equine name to promote NVRHA objectives and activities including, but not limited to, use by third parties with authorization from NVRHA.
6. All participants agree to adhere to and follow all CDC and all federal, state and local guidelines regarding COVID 19 & social distancing while participating in NVRHA events.
